First-aid measures general

4.2. Most important symptoms and effects, both acute and delayed

Symptoms/injuries

Symptoms/injuries after inhalation

Harmful if inhaled. Danger of serious damage to health by prolonged exposure through inhalation. Inhalation of phenol vapors can lead to damage of the bronchial system and pulmonal oedema. Systemic damage to kidneys, liver and heart as well as neuropsychiatric disturbances are produced. Excessive concentrations may cause nervous system depression, headache, and weakness leading to unconsciousness. Causes damage to liver through prolonged or repeated exposure if inhaled. Difficulty in breathing. May cause allergy or asthma symptoms or breathing difficulties if inhaled. May cause cancer by inhalation. May cause respiratory irritation.

Symptoms/injuries after skin contact

: Harmful in contact with skin. Repeated exposure to this material can result in absorption through skin causing significant health hazard. May cause an allergic skin reaction. Causes severe skin burns and eye damage. Strong skin absorption as main danger of phenol poisoning at the workplace with paralysis of th central nervous system (with lethal consiquences in severe cases) as well as liver and kidney damage. Phenol destroys the nerve endings in the skin. Therefore absence of pain does not necessarily mean the skin has been properly decontaminated.
